By executing this document you will waive certain legal rights, including the right to sue. Please read carefully.

1. This is a binding legal agreement and as a Participant in the sport of volleyball and the activities, events and programs of the Organization, the undersigned acknowledges and agrees to the following terms:

Disclaimer

2. The Ontario Volleyball Association, Volleyball Canada, all other associations, sanctioning bodies and sponsoring companies and all their respective employees, agents, servants, contractors, representatives, elected and appointed officials, and successors and assigns (collectively the "Organization") are not responsible for any injury, personal injury, damage, property damage, expense, loss of income or loss of any kind suffered by a Participant during, or as a result of, the sport of beach volleyball and any program, activity or event of the Organization, caused in any manner whatsoever including, but not limited to, the negligence of the Organization.

Description of Risks

3. I am participating voluntarily in the sport of volleyball and the activities, events and programs of the Organization. In consideration of my participation in the sport of volleyball and the programs, activities and events of the Organization, I hereby acknowledge that I am aware of the risks, dangers and hazards associated with or related to the sport of volleyball and any such programs, activities and events of the Organization, including injuries which can be **severe and even fatal**. The risks, dangers and hazards include, but are not limited to, injuries from:

- a) Exerting and stretching various muscle groups and strenuous cardiovascular workouts;
- b) Vigorous physical exertion, rapid movements and quick turns and stops;
- c) Falling, tumbling or hitting other participants, the ground or sand;
- d) Contact, colliding or being struck by the volleyball, net, poles, other individuals, equipment, walls, stands, or benches;
- e) Failing to play within one's abilities and within designated areas;
- f) Failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment;
- g) Animal attacks; including but not limited to, dogs, snakes, etc.;
- h) Extreme weather conditions which may result in heatstroke, sunstroke or lightning strikes;
- i) Spinal cord injuries which may render me permanently paralyzed; or
- j) Travel to and from competitive events and associated non-competitive events which are an integral part of the Organization's activities.

4. Furthermore, I am aware:

- a) That injuries sustained can be severe and that my risk of injury increase as I become fatigued;
- b) That I may experience anxiety while challenging myself during the activities, events and programs and
- c) That my risk of injury is reduced if I follow all rules established for participation.

Release of Liability

5. In consideration of the Organization allowing me to participate, I agree:

- a) That my physical condition has been verified to participate in the activities, events and programs of the Organization by a medical doctor;
- b) To waive any and all claims that I may have now or in the future against the Organization related to my participation, personal safety and loss or damage to personal property;
- c) To freely accept and fully assume all such risks and possibility of personal injury, death, property damage, expense and related loss, including loss of income, resulting from my participation in the sport of beach volleyball and the activities, events and programs of the Organization; and
- d) To forever release, waive and discharge the Organization from any and all liability for any and all claims, demands, actions, damages, expenses, causes of action and costs, whether in law or equity, that might arise out of my participation in the activities, events and programs of the Organization, whether as a spectator, participant, competitor or otherwise, due to any cause whatsoever, even though such risks, injuries, loss, death, damage, claims, demands, actions or costs may have been caused by the

negligence or breach of any duty of care of the Organization, whether prior to, during or subsequent to the activity, event or program of the Organization.
